Dr. P. V. Madhusudhan Rao:

Dr. P. V. Madhusudhan Rao is a professor in the Department of Mechanical Engineering and Design at IIT Delhi. He was also the founding head of the Department of Design. He is a co-founder of the Assistech lab in the Khosla School of Information Technology, which works towards the development of assistive technologies for the empowerment of the visually challenged. As a coordinator of IIT Delhi Design Innovation Center (DIC), he is also responsible for initiating and driving multiple programs in design, innovation & entrepreneurship. He obtained his bachelor's in mechanical engineering from the College of Engineering, Osmania University, master's in mechanical engineering from IIT BHU, and his Ph.D from IIT Kanpur. He was a guest researcher at the US government's National Institute of Standards & Technology (NIST, USA) five times. He was visiting scientists at



Massachusetts Institute of Technology and visiting faculty at Stanford University.

Shri Divyanshu Mishra:

Shri Divyanshu Mishra has been working in the field of Intellectual Property since 2016, specifically in Patent Prosecution of Mechanical and General Engineering Applications at the Indian Patent Office. Additionally, Serving as an Examiner of Patents for the International Search Authority and International Preliminary Examination Authority (under the Patent Cooperation Treaty, 1970 framework) of the World Intellectual Property Organization since 2017. Also been Serving as a NIPAM Trainer for the Indian Patent Office since Dec 2021, wherein several lectures and webinars on Intellectual Property have been delivered in different educational institutions.
